

“Starting in May 2020 the U.S. was shaken by protests, uprisings, and riots following the police murder of George Floyd. Almost immediately the government moved in to repress those taking the streets against the police and racial violence. More than 350 people were arrested on federal charges while city and state level arrests topped 14,000 between May 28th and Nov 3rd. Some cities and regions already had established organizations and crews to help with both jail support and long-term prisoner support during and after the Uprising; in other places new groups formed as the need arose; yet other places still have little or no infrastructure to support the massive number of arrestees.

The uprising was the continuation of a battle against the combined powers of the state and white supremacy that has been raging for decades; centuries. That fight does not end when the protests die down or the riots are quelled. It overlaps with other moments of rupture and with the care that we show for each other in the aftermath of repression and the build up towards the next moment. The struggle continues. And for that reason, we do not want those captured by the state to be isolated through their imprisonment and left out of that continuing struggle. We want to facilitate their connections with people, movements, and communities on the outside; this website is one piece of that effort.”

- A lot of people seem wary of telling prisoners about “fun” stuff, thinking it will depress them or make them feel homesick hearing about people having a laugh on the outside. This is rubbish! They’ll already be homesick and it’s just reassuring to hear normal life is going on so don’t feel coy about mentioning shows, parties and raucous nights down the boozier.
- Always ask a few questions like how they’re doing, plans they have for the future, what their interests are, etc. but try to keep it general and don’t make it sound like you’re being nosey. Bearing in mind that they might be replying to a total stranger, it makes writing a response a lot easier.
- Similarly, some background about yourself, even seemingly trivial things like favorite bands, football teams etc, can make writing a reply that bit easier...
- Don’t EVER promise things you can’t deliver. If you build someone’s hopes up about say visiting them, sending things into them, etc then you let them down, that’s well out of order and hardly consistent with supporting them.
- Avoid turgid lefty-isms! Phrases like “my comrades and I have resolved to pass a motion of solidarity” sound pompous and impersonal however well-meaning they might be. “We hope you’re doing ok” is a lot more friendly!
- Political literature – be careful! Unless the prisoner asks for it, avoid sending any overly contentious political material in as it can potentially cause them grief. There’s no problem sending this kind of thing as long as you ask the prisoner first and always respect their wishes.
- Introduce yourself - tell them your name, location, how you found out about them, and, if it’s relevant, what group you’re affiliated with.
- Be upfront about how often you’ll be able to write. It’s fine if you’re only intending to send a single letter of support, just be clear so you don’t set up an expectation of writing regularly if you can’t realistically commit to that.

## David Elmakayes

*Is this the “land of the free”? The land that was promised to our ancestors that died fighting to create “this land”? As he was on probation at the time of his indictment he was additionally given a 1-10 year state sentence for probation violation." ## What to Write

It's normal to feel intimidated or anxious about writing to a prisoner for the first time. People express this to us all the time, and we understand - you've never met the person before, you don't know what to say, you're not sure what things are okay and not okay to talk about... and cops might read your letter.

Just keep in mind that prisoners are regular people like us, and everyone is different. We can't tell you exactly what to write. We can only encourage you to be yourself so that diverse and genuine connections can be built. We can offer some general tips to help you get past any initial writer's block, though:

- Share some updates on what's going on in the outside world, especially things that are significant to you. Don't be afraid to give lots of details - letters are one of few links to the outside world that many prisoners have, so words and stories that can evoke vivid sounds, smells, tastes, images, and feelings can be very impactful.
- If you're not great with words, share a poem or some lyrics that you like. Or draw something! Or, if the rules permit, add articles or photographs; you can write in some commentary to personalize them.
- If the prisoner is in for a political offense you should obviously let them know you support their actions but don't start praising them as some sort of hero to the cause. Rhetoric to the effect of "I'm in awe of your great sacrifice blah, blah..." is frankly cringe-worthy. If someone is caught up for a political action they probably don't want to be seen as martyrs - they're just normal people unlucky enough to get caught, so write to them like normal people rather than fawning!
- Ask questions like you would with anyone else you were getting to know. What's their favorite food or movie? What are their interests?

"My name is Malik Farrad Muhammad. I'm a 26-year-old black/Palestinian pansexual Muslim (yes, hella confusing). I'm an anarchist antifascist, anti-racist abolitionist (yes, both cops and prisons) for my love of freedom! My first protest was in high school: a walkout staged after Treyvon Martin's murder. From there, I never really got active again until "Bernie or Bust" and then, of course, the George Floyd uprising. I traveled the country and organized and fought and was ultimately kidnapped, ransomed, and now held prisoner here at OSP. I have a beautiful son, a beautiful wife and life partner, Jesse, who moved out here to Portland after my kidnapping by the feds, and a loving family back home in the Midwest. I'm also a veteran, I was a tanker in the army — and no, I'm not proud that I was part of the murder machine, so don't thank me for my service. I love music more than anything almost, am a guitarist and aspiring pianist, all genres.

Not much else to say except that I'm a lover of freedom, equity and equality, and will fight to my last breath for it. Unlike those who may regret a thing they did to get convicted or those who tempered their actions for fear of the consequences, I regret nothing, if only not doing more before I was caught. I will live for the people and I'll die for the people because I love the people, we who want freedom cannot rest till it comes."

## Montez Lee

On January 14th, 2022, Montez Lee was sentenced to 10 years in prison, having pled guilty to one count of arson after facing multiple federal charges and being held without bond after his arrest. From Minnesota Uprising Arrestee Support: “My name is Montez Lee. I am a 25 year old African American male from Rochester, MN. I am father to two kids. I am being charged by the federal government on the charges of 1st degree arson. On May 28th, I decided to go to Minneapolis and protest with my community. I have faced injustices from local police departments myself and have been subjected to racism. I wanted to be a part of something bigger. I wanted to show my kids and peers that you fight for what you believe in. I’m sick of seeing people of color murdered by the same people sworn to serve and protect. I’m tired of people turning a blind eye to what’s going on in this country. Though I’ve been here for months fighting this case, I will not let it break my spirit or make me forget my principles. I stand with my community and my people. Until there is change and we are treated as equals, we will fight. No justice means no peace.”

At his sentencing Tyre was given a 5 year federal sentence during which Tyre told the judge “the days of just rolling over to police brutality are over.” He likes to read and write, make poetry and rhymes and he says “this time that I am away from my family friends and loved ones is only making me stronger as a man. I have no regrets.”

*What’s up Midwest Books to Prisoners? Greetings to all my comrades over there and among your readers. I just wanted to let you all know that I’m approaching my release/halfway house date after serving an unjust sentence for my role in the uprising in St. Paul after the murder of George Floyd. I hope all of you out there know that I’m grateful for the support I received from all of you there during my imprisonment. Your inclusion of my name/ information in subsequent installments of your newsletter has been greatly appreciated. In a carceral setting, just knowing that you aren’t being forgotten, that the people who share your values, your dreams, and your belief in a better world still think of you and say your name – it means the world. Inside I’m surrounded by people who have become so desensitized to cruelty and injustice, or even more incomprehensibly, support the neo-fascism infecting our world at every level. After years of this, it’s hard to keep hope and to maintain my resolve. Being reminded why I started to get involved in the first place – by seeing your regular updates of activism and direct action across the country – has helped me to not forget who I am or what is important to me. I might have lost some years, but George Floyd lost his life. That truth that perspective, grounds me. Apart from the mental and emotional strain of this experience, unfortunately a lot of other things have to be dealt with. When this all started I had a good job, years in recovery, and a stable, full, rich life like I’d never known before. I’m leaving federal prison with nothing. I have only a little family left in this world, and a whole list of things to overcome when I touch down.*

*With that in mind, I have two things to ask of you brothers & sisters. One, for all the political prisoners locked away in this system, I would ask that you continue to share the mailing/email addresses of the activists who sent you their info. That support is vital. My other request is that you update our community of my upcoming release, and let everyone know that any help when I’m touching down would be appreciated, My sister’s*
